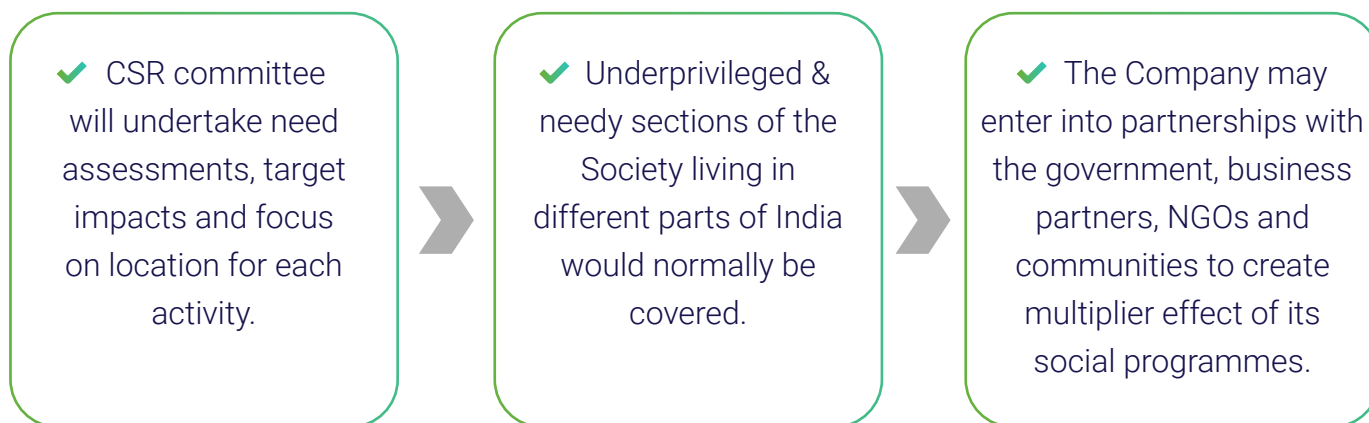


Empowering Community - Proactively engage and empower people with practical knowledge, hands-on experience and meet the specific needs of the communities.
